#### 1. Principal accounting policies

The accounting policies adopted are consistent with those set out in the annual financial statements for the year ended 31 March 2020.

The quarterly report is unaudited, but has been reviewed by the audit committee of the Company.

The Group principally operates in the People's Republic of China (the "PRC") with its business activities principally transacted in RMB, the results of the Group are therefore prepared in RMB.

#### 4. Income Tax

No provision for Hong Kong profits tax is made for current year and prior year as there is no assessable profits arising in Hong Kong for both years. Tajikistan Corporate Income Tax rate is calculated at applicable rate of 23% (for activities other than goods production) and 13% (for activity of goods production) respectively; whereas EIT is calculated at the applicable rate of 25%, except that:

- (i) One Tajikistan subsidiary is exempted from Tajikistan Corporate Income Tax for 5 years until 2022 pursuant to the investment agreement between the subsidiary and the Tajikistan government.
- (ii) Three PRC subsidiaries which have obtained the New and Hi-tech Enterprise recognition are entitled to enjoy preferential EIT rate of 15% for a period of 3 years from 25 August 2017, 3 December 2018 and 13 November 2019 respectively.
- (iii) Two branches and a subsidiary which are located in the Tibet Autonomous Region of the PRC are entitled to preferential tax rate. Based on the tax ruling announced by the PRC central tax authorities, the EIT rate of Lhasa is 9% for the years from 2015 to 2021. The EIT rate will resume to 15% from 2022 onwards if no further announcement from the PRC central tax authorities is made.

#### 4. 所得税

由於在本年度及過往年度並無於香港產生 應評税利潤,故並無於該兩個年度計提香 港利得税撥備。塔吉克斯坦企業所得税按 23%(就貨品生產以外業務而言)及13% (就貨品生產業務而言)的適用税率計算; 而中國企業所得税則按25%的適用税率計 算,惟以下除外:

- (i) 根據一家塔吉克斯坦附屬公司與塔 吉克斯坦政府訂立的投資協議,附 屬公司獲豁免塔吉克斯坦企業所得 税,為期五年至二零二二年為止。
- iii) 已取得高新技術企業資格認可的三 間中國附屬公司分別從二零一七年 八月二十五日、二零一八年十二月 三日及二零一九年十一月十三日起 三年期間可享受15%的中國企業所 得税優惠税率。
- (iii) 位於中國西藏自治區之兩家分公司 及附屬公司,可享受優惠稅率。根 據中國中央稅務機關公佈的稅務規 例,拉薩於二零一五年至二零二一 年期間的企業所得税率為9%。二 零二二年起,倘中國中央税務機關 並無進一步公佈,企業所得税率將 恢復為15%。

# MANAGEMENT DISCUSSION AND ANALYSIS FINANCIAL REVIEW

The turnover of the Group for the three months ended 30 June 2020 increased by approximately 9.06% as compared with the same period in 2019. The increase was mainly due to the Group has recently developed Tajikistan market and Tibet market which has continued to generate the enormous revenue.

The other income and gain for the three months ended 30 June 2020 increased by approximately 11.54 times as compared with the same period in 2019. The main reason is that a subsidiary of the Group received a special reward fund of RMB6.35 million from the local government.

# **CHARGE OF ASSETS**

As at 30 June 2019, certain property, plant and equipment amounted to RMB66,105,400 (2019: 97,331,000) were pledged to secure the Group's bank loans.

# BUSINESS REVIEW AND PROSPECTS

# **Business Review**

For the period ended 30 June 2020, the primary income source of the Group came from sales of civil explosives and provision of blasting services. Especially, the business of provision of blasting operations has been bringing in sustainable revenue for the Group.

# **Prospect and outlook**

On June 29, 2020, a wholly-owned subsidiary of the Company entered into a Capital Injection and Cooperation Agreement with a company engaged in the mining and processing of pyrite, iron ore and copper ore and the sale of the above mineral products, and the relevant announcement was issued. The company hopes to take this opportunity to extend the industrial chain to non-ferrous metals and precious metals mining and development industries.
