

## **CHARACTERISTICS OF GEM**

## GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES, RE-ELECTION OF DIRECTORS, DECLARATION OF FINAL DIVIDEND, PROPOSED AMENDMENTS TO THE ARTICLES OF ASSOCIATION, AND NOTICE OF ANNUAL GENERAL MEETING

#### **INTRODUCTION**

The purpose of this circular is to provide the Shareholders with information regarding the resolutions to be proposed at the Annual General Meeting for the approval of the New Issue Mandate, the Repurchase Mandate, the extension of the New Issue Mandate, the re-election of Directors, the declaration of final dividend and the Proposed Amendments to the existing Articles of Association.

At the last annual general meeting of the Company held on 24 September 2021, the Directors were granted a general mandate to allot and issue Shares and a general mandate to repurchase Shares. These mandates will expire at the conclusion of the forthcoming Annual General Meeting.

#### NEW ISSUE MANDATE

A resolution will be proposed at the Annual General Meeting to grant a general mandate to the Directors to allot, issue and deal with new Shares up to 20% of the issued share capital of the Company as at the date of passing the relevant resolution. In addition, subject to the Shareholders' approval at the Annual General Meeting, the number of Shares purchased by the Company under the Repurchase Mandate will also be added to the total number of Shares which may be allotted and issued under the New Issue Mandate as mentioned above.

As at the Latest Practicable Date, the total issued share capital of the Company comprised 3,558,724,852 Shares. Subject to the passing of the relevant ordinary resolution to approve the New Issue Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the Annual General Meeting, the Company would be allowed under the New Issue Mandate to allot a maximum of 711,744,970 Shares.

#### **REPURCHASE MANDATE**

A resolution will be proposed at the Annual General Meeting to grant to the Directors to exercise the powers of the Company to repurchase on the Stock Exchange or on any other stock exchange on which the Shares may be listed up to 10% of the issued share capital of the Company as at the date of passing the relevant resolution.

As at the Latest Practicable Date, the total issued share capital of the Company comprised 3,558,724,852 Shares. Subject to the passing of the relevant ordinary resolution to approve the Repurchase Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to purchase a maximum of 355,872,485 Shares on the market.

The GEM Listing Rules contain provisions to regulate the repurchase by companies with a primary listing on GEM of their own shares. In compliance with the GEM Listing Rules, an explanatory statement is set out in the appendix to this circular. The information on the explanatory statement is to provide you with requisite information reasonably necessary to enable the Shareholders to make an informed decision on whether to vote for or against the resolution to approve the granting of the Repurchase Mandate to the Directors.

The New Issue Mandate and the Repurchase Mandate will expire at the earliest of: (a) the conclusion of the next annual general meeting of the Company following the Annual General Meeting; (b) the expiration of the period within which the next annual general meeting of the Company following the Annual General Meeting is required by the Articles of Association or any applicable laws to be held; or (c) the passing of an ordinary resolution by the Shareholders in general meeting revoking or varying the authority given to the Directors.

#### EXTENSION OF THE NEW ISSUE MANDATE

An ordinary resolution will also be proposed at the Annual General Meeting to authorise the Directors to extend the New Issue Mandate by a number representing the aggregate number of the Shares repurchased under the Repurchase Mandate.

#### **RE-ELECTION OF DIRECTORS**

According to article 86(3) of the Articles of Association, the Directors shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or, as an addition to the existing Board. Any Director so appointed by the Board shall hold office only until the next following annual general meeting of the Company, and shall then be eligible for re-election at that meeting.

Also according to article 87(1) of the Articles of Association, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation. Article 87(2) further provides that a retiring Director shall be eligible for re-election and any further Directors so to retire shall be subject to retirement by rotation who have been longest in office since their last re-election or appointment.

In accordance with the Articles of Association, Mr. Ma Tianyi, Ms. Qin Chunhong, Ms. Zhang Jinghua and Mr. Ha Suoku will retire from office at the forthcoming Annual General Meeting. The retiring Directors, being eligible, will offer themselves for re-election.

The biographical details of the retiring Directors eligible for re-election at the Annual General Meeting are set out below:

#### 1. Mr. Ma Tianyi ("Mr. Ma"), an executive Director and chief executive officer of the Company

Age: 27

#### Length of service

Mr. Ma has been appointed as an executive Director of the Company since 1 March 2017 and has been appointed as the chief executive officer of the Company on 1 May 2021. Such appointment is subject at all times to the Articles of Association. Mr. Ma will retire at the Annual General Meeting and, being eligible, offer himself for re-election pursuant to articles 87(1) and 87(2) of the Articles of Association.

#### *Qualification and experience*

Mr. Ma graduated from Downing College, University of Cambridge in June 2016 with a Bachelor's Degree in Arts, specializing in Natural Sciences Tripos and obtained the qualification on Master of Business Administration from the University of Hong Kong in 2020.

#### Relationship with other Directors, senior management, substantial or controlling Shareholders

Mr. Ma is the son of Mr. Ma Qiang who was the former chairman and former executive Director of the Company. Mr. Ma is also the nephew of Mr. Liu Fali, the chief operating officer and an executive Director of the Company and nephew of Ms. Ma Ye, an executive Director of the Company.

Save as disclosed herein, Mr. Ma does not have any relationship with any other Directors, senior management, the substantial Shareholders or controlling Shareholders.

#### Interests in the Shares

As at the Latest Practicable Date, Mr. Ma was interested in 7,480,000 Shares, representing approximately 0.21% of the issued share capital of the Company, within the meaning of Part XV of the SFO.

#### Amount of emoluments

Under the latest service contract entered into between the Company and Mr. Ma, he is entitled to annual remuneration of HK\$720,000 which was determined by reference to his roles and responsibilities and prevailing market conditions. Save for such remuneration, Mr. Ma is not entitled to any other emolument for holding his office as an executive Director and the chief executive officer of the Company.

#### Other information

# 2. Ms. Qin Chunhong ("Ms. Qin"), an executive Director, the compliance officer, and a member of the remuneration committee

Age: 49

#### Length of service

Ms. Qin has been appointed as an executive Director, the compliance officer, and a member of the remuneration committee of the Company commencing from 14 December 2012. Such appointment is subject at all times to the Articles of Association. Ms. Qin will retire at the Annual General Meeting and, being eligible, offer herself for re-election pursuant to articles 87(1) and 87(2) of the Articles of Association.

#### Qualification and experience

She obtained a Master's degree in business administration from the School of Business Administration in Peking University in July 2009. She also obtained a Bachelor's degree in economics from Henan Institute of Finance and Economics in June 2003. She has been a member of the China Certified Tax Agents Association since September 2009 and a member of the Chinese Institute of Certified Public Accountants since 2000. Ms. Qin has been the chief financial officer of Beijing Shenshi Huaxuan Investment Co. Ltd. (北京盛世華軒投資有限公司) since 2010. She was also the chief financial officer of Inner Mongolia Shuangli Resources Group Co., Ltd. (內蒙古雙利資源 (集團) 有限責任公司) from 2006 to 2009 and the chief financial officer of Western Mining Group (Hong Kong) Company Limited from 2005 to 2006. Since 2013, Ms. Qin has been the chief financial officer of Tibet Fudeyuan Trading Limited (西藏福德圓實業集團有限公司).

#### Relationship with other Directors, senior management, substantial or controlling Shareholders

Ms. Qin does not have any relationship with any other Directors, senior management, the substantial Shareholders or controlling Shareholders.

#### Interests in the Shares

As at the Latest Practicable Date, Ms. Qin was interested in 36,564,908 Shares, representing approximately 1.03% of the issued share capital of the Company, within the meaning of Part XV of the SFO.

#### Amount of emoluments

Under the terms of the appointment letter to Ms. Qin, she is entitled to annual remuneration of HK\$240,000 which was determined by reference to her roles and responsibilities and prevailing market conditions. Save for such remuneration, Ms. Qin is not entitled to any other emolument for holding her office as an executive Director, the compliance officer and a member of the remuneration committee of the Company.

#### Other information

# 3. Ms. Zhang Jinghua ("Ms. Zhang"), an independent non-executive Director and the chairperson of the audit committee and remuneration committee and a member of the nomination committee of the Company

Age: 47

#### Length of service

Ms. Zhang was appointed as an independent non-executive Director and the chairperson of the audit committee and remuneration committee and a member of the nomination committee of the Company commencing from 1 December 2021, and such appointment is subject at all times to the Articles of Association. Ms. Zhang will retire at the Annual General Meeting and, being eligible, offer herself for re-election pursuant to articles 86(3) and 87(2) of the Articles of Association.

#### Qualification and experience

Ms. Zhang, graduated from Georgia State University in May 2000 with a Master Degree in Accounting. She was licensed as a certified public accountant (inactive) in Richmond VA, the United States from October 2002. She has over 20 years of financial management experience.

#### Relationship with other Directors, senior management, substantial or controlling Shareholders

Ms. Zhang does not have any relationship with any other Directors, senior management, substantial Shareholders or controlling Shareholders.

#### Interests in the Shares

As at the Latest Practicable Date, Ms. Zhang did not have any interests in the Shares within the meaning of Part XV of the SFO.

#### Amount of emoluments

Under the service agreement entered into between the Company and Ms. Zhang, she is entitled to an annual remuneration of HK\$120,000 which was determined with reference to her roles and responsibilities and the prevailing market conditions. Save for the said salary, Ms. Zhang is not entitled to any other emolument for holding her office as an independent non-executive Director, the chairperson of the audit committee and remuneration committee and a member of the nomination committee of the Company.

# 4. Mr. Ha SuoKu ("Mr. Ha"), an independent non-executive Director, a member of the audit committee and remuneration committee, and the chairperson of the nomination committee of the Company

Age: 49

#### Length of service

Mr. Ha was appointed as an independent non-executive Director, a member of the audit committee and remuneration committee, and the chairperson of the nomination committee of the Company commencing from 1 December 2021, and such appointment is subject at all times to the Articles of Association. Mr. Ha will retire at the Annual General Meeting and, being eligible, offer himself for re-election pursuant to articles 86(3) and 87(2) of the Articles of Association.

#### Qualification and experience

Mr. Ha graduated from Department of Economics, Inner Mongolia University in July 1994. He has over 20 years of securities and futures investment experience.

#### Relationship with other Directors, senior management, substantial or controlling Shareholders

Mr. Ha does not have any relationship with any other Directors, senior management, substantial Shareholders or controlling Shareholders.

#### Interests in the Shares

As at the Latest Practicable Date, Mr. Ha did not have any interests in the Shares within the meaning of Part XV of the SFO.

#### Amount of emoluments

Under the service agreement entered into between the Company and Mr. Ha, he is entitled to an annual remuneration of HK\$120,000 which was determined with reference to his roles and responsibilities and the prevailing market conditions. Save for the said salary, Mr. Ha is not entitled to any other emolument for holding his office as an independent non-executive Director, a member of the audit committee and remuneration committee, and the chairperson of the nomination committee of the Company.

#### Other information

#### **DECLARATION OF FINAL DIVIDEND**

The Board proposes to declare a final dividend of HK0.01 per share for the year ended 31 March 2022 (the "Final Dividend") at the Annual General Meeting for the Shareholders to approve. The Final Dividend will be paid out of the share premium of the Company which is permitted under the Companies Act and the Articles of Association. The Board is of the view that after payment of the Final Dividend, the Company will be able to pay its debts as they fall due in the ordinary course of business.

#### PROPOSED AMENDMENTS TO THE ARTICLES OF ASSOCIATION

At the Annual General Meeting, a special resolution will be proposed in respect of the approval of the Proposed Amendments and the proposed adoption of the Amended and Restated Articles of Association.

Reference is made to the announcement of the Company dated 22 June 2022. The Board proposes to amend the existing Articles of Association in order to (i) bring the Articles of Association in line with the amendments made to the applicable laws of the Cayman Islands and the GEM Listing Rules, in particular Appendix 3 to the GEM Listing Rules regarding the core shareholder protection standards which became effective on 1 January 2022; (ii) incorporate certain consequential and housekeeping amendments; and (iii) update and clarify provisions where it is considered desirable. As such, the Board proposes to adopt the Amended and Restated Articles of Association in substitution for, and to the exclusion of, the existing Articles of Association.

The principal effects of the Proposed Amendments to the existing Articles of Association are summarised as follows:

- 1. to bring the Amended and Restated Articles and Association to conform to the core shareholder protection standards that apply to all issuers to provide the same level of protection to all investors as set out in Appendix 3 to the GEM Listing Rules;
- 2. to provide that an extraordinary general meeting may be convened on the written requisition of one or more Shareholder(s) holding, as at the date of deposit of the requisition, not less than 10% of the paid up capital of the Company carrying the right of voting at general meetings of the Company, and that such Shareholder(s) shall be entitled to add resolutions to the agenda of the extraordinary general meeting concerned;
- 3. to provide that the Company must give its Shareholders written notice of at least 21 clear days for an annual general meeting and at least 14 clear days for other general meetings;
- 4. to provide that the Company must hold its annual general meeting within six months after the end of its financial year;
- 5. to provide that all Shareholders have the right to (a) speak at a general meeting; and (b) vote at a general meeting except where a Shareholder is required, by the rules of the designated stock exchange, to abstain from voting to approve the matter under consideration;

- 6. to clarify that the Shareholders may by way of ordinary resolution remove any Director (including a managing Director or other executive Directors) at any time before the expiration of his/her term of office;
- 7. to provide that the appointment, removal and remuneration of the Company's auditors must be approved by a majority of the Shareholders;
- 8. to incorporate provisions that allow the Company to hold general meetings via electronic means or as a hybrid meeting with both physical and virtual attendance and participation by the Shareholders and incidental changes, and setting out the powers of the Board and the chairman of the meeting in relation thereto;
- 9. to supplement the provisions on adjournment of general meetings in light of addition of electronic meeting provisions, as well as providing for postponement of general meeting by reason of, among other things, typhoon signal no. 8 or above or black rainstorm warning;
- 10. to provide that in relation to convening a general meeting, the notice of a general meeting shall specify the particulars of the resolutions, time and date of the meeting, the place of the meeting (save for an electronic meeting) and the Principal Meeting Place (as defined in the Amended and Restated Articles of Association) if there is more than one meeting location as determined by the Board. If the general meeting is to be a hybrid meeting or an electronic meeting, the notice shall include details of the electronic facilities;
- 11. to clarify that a physical meeting may also be held by means of such telephone, electronic or other communication facilities as to permit all persons participating in the meeting to communicate with each other simultaneously and instantaneously, and participation in such a meeting shall constitute presence in person at such meeting;
- 12. to clarify that the Company is authorised to make payments in respect of the purchase of the Shares out of capital or out of any other account or fund which can be authorised for this purpose in accordance with the Companies Act;
- 13. to provide that the Board may accept the surrender for no consideration of any fully paid shares;
- 14. to remove certain requirements in relation to the redemption of redeemable shares from the Articles of Association;
- 15. to provide that the seal of the Company may only be affixed or imprinted to a share certificate with the authority of the Directors, or be executed under the signature of appropriate officials with statutory authority, unless otherwise determined by the Directors;
- 16. to clarify certain requirements in relation to the exercise of the Company's power to sell any shares of a Shareholder who is untraceable;

- 17. to amend the Articles of Association so that they provide that the chairman of a general meeting may, in good faith, allow a resolution which relates purely to procedural or administrative matters to be voted on by a show of hands instead of by poll;
- 18. to allow the Company to provide an electronic address for the receipt of any document or information relating to proxies for a general meeting;
- 19. to allow the Board to decide to treat a proxy appointment as valid notwithstanding that the appointment or any of the information has not been received in accordance with the requirements under the Amended and Restated Articles of Association;
- 20. to prevent the Company from making any loan to a Director or his/her close associate if and to the extent it would be prohibited by the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) as if the Company were a company incorporated in Hong Kong;
- 21. to empower the Board to capitalise certain reserves of the Company, including a share premium account and the profit and loss account, to pay up unissued shares to be allotted to employees or trustee in connection with the operation of any share incentive scheme or employee benefit scheme that has been adopted or approved by the Shareholders at a general meeting;
- 22. to provide that any auditor appointed by the Directors to fill any casual vacancy in the office of auditor shall hold office until the next following annual general meeting of the Company at which further appointment is subject to the approval of the Shareholders by ordinary resolution, and that the remuneration of the auditor for the further appointment shall be fixed by the Shareholders by ordinary resolution in general meeting or in such manner as the Shareholders may determine;
- 23. to include or revise certain defined terms to align with the applicable laws of the Cayman Islands, the GEM Listing Rules and the relevant provisions in the Articles of Association including "Act", "announcement", "close associate", "electronic communications", "electronic meeting", "hybrid meeting", "Listing Rules", "Meeting Location", "ordinary resolution", "physical meeting", "Principal Meeting Place", "special resolution" and "substantial shareholder";
- 24. to provide that 31 March be the financial year end of the Company; and
- 25. to make other housekeeping amendments, including making consequential amendments in line with the above amendments to the Articles of Association.

The legal advisers to the Company as to Hong Kong laws have confirmed that the Proposed Amendments conform with Appendix 3 to the GEM Listing Rules, and on the whole, are not inconsistent with the GEM Listing Rules. The legal advisers to the Company as to the laws of the Cayman Islands have confirmed that the Proposed Amendments do not violate the applicable laws of the Cayman Islands. The Company has also confirmed that there is nothing unusual about the Proposed Amendments for a company listed in Hong Kong.

Details of the Proposed Amendments are set out in Appendix II to this circular. The Chinese translation of the Proposed Amendments is for reference only. In case of any discrepancy or inconsistency between the English and Chinese versions, the English version shall prevail. Prior to the passing of the special resolution at the Annual General Meeting, the existing Articles of Association shall remain valid.

Accordingly, the Board proposes to seek approval of the Shareholders by way of special resolution for the approval of the Proposed Amendments and the proposed adoption of the Amended and Restated Articles of Association at the Annual General Meeting.

The following is the explanatory statement which is required to be sent to you under Rule 13.08 of the GEM Listing Rules in connection with the proposed general mandate for repurchase of Shares.

#### (i) The Repurchase Mandate

The resolution set out in Resolution 6 of the notice convening the Annual General Meeting will be proposed at the Annual General Meeting to grant a general and unconditional mandate to the Directors to repurchase, on GEM or any other stock exchange on which the Shares may be listed and recognised by the Securities and Futures Commission, Shares up to a maximum of 10% of the issued share capital of the Company at the date of passing of the resolution.

The Repurchase Mandate would continue in force until the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws of the Cayman Islands to be held or the Repurchase Mandate is revoked or varied by an ordinary resolution in a general meeting by Shareholders, whichever is the earliest.

#### (ii) Reasons for repurchase

Although the Directors have no present intention of repurchasing the Shares, they believe that it is in the best interests of the Company and its shareholders for the Directors to have a general authority from the shareholders to enable the Company to repurchase Shares in the market. Such repurchase may, depending on the market conditions and funding arrangement at the time, lead to an enhancement of the net assets value of the Company and/or its earnings per share and will only be made when the Directors believe that such a repurchase will benefit the Company and its shareholders.

#### (iii) Share capital

As at the Latest Practicable Date the issued share capital of the Company comprised 3,558,724,852 Shares. Subject to the passing of the resolution approving the Repurchase Mandate, the Company would be allowed under the Repurchase Mandate to repurchase Shares up to a maximum of 355,872,485 Shares (assuming that there is no change in the issued share capital of the Company from the Latest Practicable Date to the date of the Annual General Meeting), representing not more than 10% of the total issued share capital of the Company as at the date of the passing of the Resolution 5.

#### (iv) Funding of repurchase

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with the memorandum of association and Articles of Association of the Company, the GEM Listing Rules and the applicable laws of the Cayman Islands. Any premium payable on a repurchase over the par value of the shares may be effected out of funds of the Company which would otherwise be available for dividend or distribution or out of the Company's share premium account. The Company may not repurchase Shares on GEM for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange.

There may be an adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited financial statements contained in the 2022 Annual Report in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the power to repurchase Shares pursuant to the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

If as a result of repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase may be treated as an acquisition for the purpose of the Takeovers Code. The result of the poll shall be deemed to be the resolution of the meeting. The Company shall only be required to disclose the voting figures on a poll if such disclosure is required by the Listing Rules.

- (a) subject to paragraph (b) of this resolution, the exercise by the Directors during the Relevant Period (as hereinafter defined) of all powers of the Company to purchase its shares on GEM or any other stock exchange on which the Shares may be listed and which is recognised by The Securities and Futures Commission of Hong Kong (the "Securities and Futures Commission") and the Stock Exchange for such purpose, in accordance with the rules and regulations of the Securities and Futures Commission, the Stock Exchange or of any such other stock exchange from time to time and all applicable laws in this regard, be and is hereby generally and unconditionally approved;
